PEFC ENDORSED

The SFI Program is endorsed by the Programme for the Endorsement of Forest Certification schemes. This enhances marketing opportunities for SFI-certified Organizations in numerous countries in Europe and Asia.

FORESTS CERTIFIED TO SFI

Over 351 million acres/ 142 million hectares of forestland are certified to SFI Forest Management Standard in North America. This forest land stretches from Canada's Boral forest to the U.S. South.

Currently there is approximately 39.1 million hectares of forestland in B.C., 14.6 million hectares in Alberta and 4.8 million hectares in Saskatchewan certified to the SFI Program.
